

QVC SCOTT LIVING SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

OPEN ONLY TO ELIGIBLE LEGAL RESIDENTS OF THE 48 CONTIGUOUS UNITED STATES (EXCLUDING RHODE ISLAND) AND THE DISTRICT OF COLUMBIA WHO ARE AT LEAST 18 YEARS OLD AT THE TIME OF GAME PLAY.

VOID IN RHODE ISLAND, PUERTO RICO AND WHERE PROHIBITED OR RESTRICTED BY LAW.

The QVC Scott Living Sweepstakes ("Promotion") is sponsored by QVC, Inc. ("Sponsor"), Studio Park – 1200 Wilson Dr., West Chester, PA, 19380, and is administered by Prize Logic, LLC ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. PROMOTION TIMING:** The Promotion begins at 12:00 PM (noon) Eastern Time ("ET") on February 22, 2016 and ends at 11:59:59 PM ET on March 19, 2016 ("Promotion Period"). The Promotion consists of a Sweepstakes ("Sweepstakes") and an Instant Win Game ("Game"). The Administrator's computer is the official clock of the Promotion.
- 2. ELIGIBILITY:** The Promotion is offered only to legal residents of the 48 contiguous United States (excluding residents of Rhode Island) and the District of Columbia who are at least 18 years old at the time of entering. Employees, officers and directors of Sponsor, Administrator, and/or their respective parent companies, affiliates, subsidiaries, advertising, promotion and production agencies ("Promotion Entities"), and each of their respective immediate family members (*i.e.*, spouse, parent, child, sibling and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Promotion. Void in Rhode Island, Puerto Rico, all United States Territories and Possessions and overseas military installations, outside of the United States, and where prohibited or restricted by law. All federal, state and local laws apply. For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical address or e-mail address.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Any entrant suspected of or found by Sponsor to be entering by automatic, programmed, script, bot, third-party or otherwise fraudulent method, in Sponsor's sole discretion, will be disqualified from the entire Promotion and all entries made by such methods will be ineligible to win.

- 3. HOW TO REGISTER FOR THE PROMOTION:** During the Promotion Period, an eligible entrant must log on to <http://gvcsweepstakes.com/> ("Website") and provide his/her valid e-mail address. If it is an entrant's first time entering the Promotion, he/she must register for the Promotion by entering the information required on the registration form, which may include: complete first name and last name (no initials), residential street address (no P.O. Boxes), city, state, ZIP Code, and confirmation that he/she satisfies the age of eligibility requirement and agrees to these Official Rules. Personally identifiable information will be collected and

used in accordance with Sponsor's Privacy Policy, as further described in Section 9 of these Official Rules. An entrant will only need to register once during the entire Promotion Period.

How to Play the Game: During the Promotion Period, after registering for the Promotion (or if already registered), the entrant must follow the on-screen instructions to play the Game (a "Game Play"). Each day when an entrant logs on to the Website after registering, he/she must enter his/her e-mail address provided during registration to receive another Game Play. After an entrant completes a Game Play, he/she will receive a win or lose message. Each entrant who receives a winning message will be deemed to be a potential "Game Winner" of the prize displayed on-screen, pending confirmation and verification of the entrant's Game Play, eligibility and compliance with these Official Rules as determined by Sponsor in its sole and absolute discretion. All potential winning Game Plays are subject to verification by Sponsor or Administrator, whose decisions are final and binding. An entrant is not a winner of any prize, even if the Promotion/Website should so indicate, unless and until entrant's eligibility and the potential winning Game Play have been verified and entrant has been notified that verification is complete. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process. Any Game Play that occurs after the system has failed for any reason is deemed a defective play, is void, and will not be honored.

How to Enter the Sweepstakes: After completing a Game Play, the entrant will automatically receive one (1) Sweepstakes entry.

Limit one (1) Game Play/Sweepstakes entry per entrant per day during the Promotion Period. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day, except on February 22, 2016, when a day starts at 12:00 PM ET and ends at 11:59:59 PM. In the event that a household enters the Promotion using more than five (5) unique e-mail addresses, all of the Game Plays/Sweepstakes associated with that household (determined by Sponsor or Administrator in their sole discretion) may be disqualified. If it is discovered or suspected, in Sponsor's sole discretion, that an entrant plays or attempts to receive more than one (1) Game Play/Sweepstakes entry in a day or more than the stated limit of Game Plays/Sweepstakes entries in the Promotion, all of that entrant's Game Plays/entries, in Sponsor's sole discretion, may be declared null and void and any prize(s) he/she might have been entitled to will not be awarded to him/her. If it is discovered or suspected, in Sponsor's sole discretion, that an entrant has registered or attempted to register for the Promotion using multiple e-mail addresses or identities, all of that entrant's registrations, in Sponsor's sole discretion, may be declared null and void and any prize(s) he/she might have been entitled to will not be awarded to him/her.

4. SWEEPSTAKES WINNER SELECTION: On or about March 21, 2016, Administrator will randomly select one (1) potential "Sweepstakes Winner", as set forth in Section 5 below, from among all eligible Sweepstakes entries received during the Promotion Period. The Sweepstakes Winner is deemed to be a potential winner, pending confirmation and verification of the entrant's eligibility and compliance with these Official Rules as determined by Sponsor or Administrator, in their sole and absolute discretion.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

A. Sweepstakes Prize (1): One (1) Sweepstakes Winner will receive a trip for two (2) people (Sweepstakes Winner and one (1) guest of his/her choosing) to QVC Studios in West Chester, Pennsylvania to meet the Scott Brothers ("Sweepstakes Prize"). The Sweepstakes Prize includes coach class airfare for two (2) people between the major

commercial airport closest to Sweepstakes Winner's residence (as determined by Sponsor in its sole discretion) and, West Chester, Pennsylvania; up to two (2) nights hotel accommodations at a hotel determined by Sponsor in its sole discretion (single room, double occupancy); an opportunity to meet Drew Scott and Jonathan Scott, subject to availability; ground transportation for Sweepstakes Winner and guest while in West Chester, Pennsylvania; a selection of Scott Living™ Products (to be determined by Sponsor in its sole discretion, the value of which shall not exceed \$500); and a \$500 QVC Gift Card. In the event a winner resides within 250 miles of West Chester, Pennsylvania (as determined by Sponsor in its sole discretion), ground transportation may be provided in lieu of air transportation, and no compensation will be provided for any difference in prize value. The ARV of the Sweepstakes Prize is \$4,300. The ARV may vary depending on the city of departure and fluctuations in airfare charges and hotel rooms. Any difference between the actual value of the Sweepstakes Prize and the stated ARV (if less than the actual value) will not be awarded. See Section 6 below for Sweepstakes Prize terms and restrictions, including but not limited to, how to claim the Sweepstakes Prize.

B. Game Prizes (26): Each Game Winner will receive a \$25 QVC Gift Card ("Game Prize").

All Game Prizes will be awarded as long as there are a sufficient number Game Plays received or eligible Game Winners. See Section 6.B. and 6.C below for Game Prize terms and restrictions, including but not limited to, how to claim a Game Prize.

C. Total ARV: The total ARV of all Prizes available during the Promotion Period is \$4,950.

D. Odds of Winning: The odds of winning the Sweepstakes Prize depends on the total number of Sweepstakes entries received during the Promotion Period. Game Prizes will be made available at random times throughout the Promotion Period, in accordance with the schedule set forth above. To be a Game Winner, an entrant's Game Play must have occurred either at the exact randomly predetermined winning time as determined by Administrator. If a Game Play does not occur at the exact randomly predetermined winning time, then the next entrant's Game Play to occur after that time will be a Game Winner. If an entrant receives a valid winning message, he/she will be deemed a potential Game Winner pending confirmation and/or verification of his/her eligibility and compliance with these Official Rules as determined by Sponsor in its sole discretion. The number of Game Prizes available to be won will decrease during the Promotion Period as Game Prizes are awarded and claimed.

E. Prize Limits: Limit one (1) Game Prize per person and per household. An entrant/household may win both a Game Prize and the Sweepstakes Prize.

6. HOW TO CLAIM PRIZES:

A. Sweepstakes Prize & Restrictions: The potential Sweepstakes Winner will be notified via e-mail by Sponsor or its authorized designee at the e-mail address provided at the time of registration on or about March 22, 2016. Sweepstakes Winner must travel on a mutually agreed-up date with the Sponsor, or the Sweepstakes Prize will be forfeited. All travel arrangements must be reserved and scheduled by April 11, 2016 or the Sweepstakes Prize may be forfeited, at Sponsor's sole discretion. The Sweepstakes Winner's guest must be at least eighteen (18) of age. Guest will be required to complete and return a Liability & Publicity Release prior to hotel booking. Travel is subject to the restrictions and conditions set forth below. All hotel accommodation booking arrangements will be

administered by Sponsor's authorized designee. All travel must be booked prior to departure. Travel is subject to capacity controls, availability, weather, seasonal influences, and certain other restrictions, all of which are subject to change. No changes will be made to travel details once any element(s) of the travel arrangements have been booked, except at Sponsor's sole discretion. No refund or compensation will be made in the event of the cancellation or delay of any flight. Travel is subject to the terms and conditions set forth in these Official Rules and those set forth by Sponsor's travel prize supplier, as detailed in any contract issued by such supplier. If the Sweepstakes Winner elects to travel without a guest, no additional compensation will be awarded.

All costs and expenses not specifically included herein are solely the Sweepstakes Winner's responsibility. The Sweepstakes Winner and his/her guest are each solely responsible for obtaining any desired or necessary travel documents (including government-issued photo identification). The Sweepstakes Winner and his/her guest hereby acknowledges that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any part of the Sweepstakes Prize. The Sweepstakes Winner and his/her guest are responsible for all in-room charges (e.g., mini-bar, movies), telephone calls, meals, beverages, gratuities, upgrades, personal incidentals, amenities and any other fees and expenses not specifically mentioned in these Official Rules. The Sweepstakes Winner will be required to provide a major credit card upon hotel check-in and all in-room charges will be charged to the credit card.

If any Sweepstakes Prize detail or event is delayed, postponed, canceled or is not available for any reason whatsoever, the Sweepstakes Prize will be awarded with the remaining portion of the Sweepstakes Prize, and the Sweepstakes Winner will not be reimbursed for the unavailable portion of the Sweepstakes Prize. The Sweepstakes Winner and his/her guest agrees and consents that he/she may be videotaped or photographed by the Sponsor or a third party when he/she meets the Scott Brothers. The Sweepstakes Winner and his/her guest agree to sign any and all appropriate documents for the use of his/her image in as set forth above as a condition for receiving the Sweepstakes Prize.

Before being declared the Sweepstakes Winner, the potential Sweepstakes Winner will be required to execute a notarized affidavit of eligibility/liability and publicity ("Affidavit"), where permitted by law. The potential Sweepstakes Winner must return a fully executed notarized Affidavit to the Sponsor or its authorized designee within five (5) calendar days from the date it is postmarked as being sent to the potential Sweepstakes Winner or the Sweepstakes Prize may (in Sponsor's sole discretion) be forfeited. The potential Sweepstakes Winner and his/her guest may be subject to a background check before the Sweepstakes Prize is awarded and potential Sweepstakes Winner and his/her guest hereby consents to such background check. Sponsor reserves the right to disqualify the potential Sweepstakes Winner (or to not allow guest to participate in the Sweepstakes Prize) based on the results of such background check if Sponsor determines in its sole discretion that awarding the Sweepstakes Prize to any such individual might reflect negatively on the Sponsor. If the potential Sweepstakes Winner is disqualified, found to be ineligible or not in compliance with these Official Rules, declines to accept the Sweepstakes Prize, or in the event that the potential Sweepstakes Winner fails to return an executed and notarized Affidavit within the stated deadline, the Sweepstakes Prize may be forfeited, and in the Sponsor's sole discretion, the forfeited Sweepstakes Prize may be awarded to an alternate Sweepstakes Winner, selected in a random drawing from

among all remaining eligible Sweepstakes entries, as determined by Sponsor in its sole discretion.

B. Game Prizes: Each potential Game Winner will receive notification on the Website screen after the completion of the Game Play, and Sponsor will also attempt to notify such potential Game Winners via e-mail at the e-mail address provided when registering for the Promotion. Upon verification of eligibility and compliance with these Official Rules, each Game Prize will be mailed to the Game Winner at the residential street address provided when registering for the Promotion. If a potential Game Winner is found to be ineligible, is not in compliance with these Official Rules, declines to accept the Game Prize, or if the Game Prize is returned as undeliverable, the Game Prize will be forfeited, and, in Sponsor's sole and absolute discretion, may be awarded to an alternate potential winner selected at random from the remaining pool of eligible Game Plays received during the Promotion Period. Alternative potential Game Winners will be subject to the same verification of eligibility as set forth above before receiving a Game Prize. Should, after the random drawing Game Prizes still remain unclaimed, such Game Prizes will not be awarded. Sponsor will attempt to send Game Prizes to the address provided when registering for the Promotion within approximately 8 to 10 weeks from the end of the Promotion Period.

C. General: Each QVC Gift Card will not be replaced or replenished if it is lost, stolen, damaged, destroyed or used without your permission and will be voided if altered or defaced. QVC Gift Cards are redeemable for merchandise only and cannot be redeemed for cash or credit except where required by law. Use of QVC Gift Card is subject to the terms and conditions set forth on the card and available at www.qvc.com/General+Terms+and+Conditions.content.html Sponsor is not responsible for any winner's privacy or spam filter settings which may divert any Promotion e-mail, including a Sweepstakes Winner notification or any winner notification e-mail to a spam or junk folder. The right to receive a prize is non-assignable, non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Sponsor who reserves the right to substitute a prize of equal or greater value in case of unavailability of a prize or force majeure. Each winner will be solely responsible for any and all federal, state and/or local taxes imposed on the acceptance of a prize. The Sweepstakes Winner will be issued a form 1099 for tax purposes in the amount of the actual retail value of the Sweepstakes Prize and must submit his/her social security number, as required by law. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. Promotion Entities shall not be held responsible for any delays in awarding a prize for any reason. Each prize will only be awarded to a verified winner.

7. LIMITATION OF LIABILITY: The Promotion Entities are not responsible for illegible, lost, late, incomplete, stolen, misdirected, postage due, or undeliverable, e-mail, or postal mail; or for any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability, or garbled, corrupt or jumbled transmissions, service provider/Internet/web site/use net accessibility, availability, or traffic congestion, or any technical, mechanical, or typographical or other error, or unauthorized human intervention, or the incorrect or inaccurate capture of registration information, or the failure to capture, or loss of, any such information. The Promotion Entities are not responsible for any incorrect or inaccurate information, whether caused by any web site users, tampering, hacking, or by any of the equipment or programming associated with or utilized in the Promotion and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or

destruction or unauthorized access to any web site(s). The Promotion Entities are not responsible for any injury or damage, whether personal or property, to participants or to any person's computer related to or resulting from participating in this Promotion. If, for any reason, the Promotion is not capable of running as planned, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Promotion and/or proceed with the Promotion, including the selection of winner(s), in a manner it deems fair and reasonable including the selection of the winner(s) from among eligible Sweepstakes entries and/or Game Plays received prior to such cancellation, termination, modification or suspension.

In no event will more Prizes be awarded than are stated in these Official Rules. In the event that, due to technical, typographical, mechanical or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the potential winners. If for any reason, including but not limited to an administrative, printing, production, computer or other error or due to technical difficulties or incorrect announcements of any kind, more winning messages are distributed, or more prizes are claimed than are intended to be awarded according to these Official Rules, the intended number of prizes will be awarded in a random drawing from among all verified prize claims received for that prize.

DISPUTES:** THIS PROMOTION IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF PENNSYLVANIA, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN THE COUNTY OF CHESTER, PENNSYLVANIA. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION IN ACCORDANCE WITH JAMS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("JAMS RULES"). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN PENNSYLVANIA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN CHESTER COUNTY, PENNSYLVANIA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR OF THE TIME THE CAUSE OF ACTION ACCRUED, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.

Further, entrants hereby waive all rights, to: (i) claim punitive, exemplary, special, incidental, indirect and consequential damages and any other damages (whether due to negligence or otherwise), other than for actual out-of pocket costs; and (ii) have damages multiplied or otherwise increased.
